On 08/19/2010, the Illinois State Police (ISP), Zone 2 Investigations were requested by the East Moline Police Department (EMPD) to investigate allegations of delivery of alcohol to a minor and inappropriate contact with a minor by Jeff NMI Terronez (M/H,DOB:[REDACTED])

NARRATIVE SECTION

On 08/19/2010, at approximately 1:30 PM, I (Sgt. J. Costliow #3795) contacted [REDACTED] (F/U, DOB: [REDACTED] and asked when would be a good time to sit down and talk to her about her complaint to the EMPD. I informed her that the EMPD had asked the ISP to investigate the allegation, due to the person of interest being the Rock Island County State's Attorney. [REDACTED] advised she was at work currently and had a hair appointment after work in Davenport, Iowa. [REDACTED] advised she should be available around 8:00 PM. [REDACTED] advised that would be a good time for her because her daughters would be home by then and they had basically witnessed what [REDACTED] reported.

On 08/19/2010, at approximately 7:45 PM, S/A S. Seas #5153 and I met with [REDACTED] and her two daughters [REDACTED] at their residence. I suggested to [REDACTED] that it would be better if we could talk to them separately. [REDACTED] agreed and had the daughters go to their room, while [REDACTED] proceeded to the front living room area. I also told [REDACTED] that we took the complaint seriously and because of the allegation and the person the accusation was against I preferred to record the interview so that later on down the road no one could say that the other had added or deleted any part of the interview. [REDACTED] advised she understood and consented to a recorded statement for herself and her daughters. The following is a synopsis of the recorded interview with [REDACTED]. The verbatim transcribed statement will be attached to this investigative report.

[REDACTED] advised she was told by her sister [REDACTED] (F/U, DOB: [REDACTED] approximately two weeks ago that [REDACTED] (daughter) had told [REDACTED] that she had overheard a conversation at [REDACTED] that [REDACTED] had told friends that a State's Attorney was purchasing [REDACTED] alcohol.

On the evening of Sunday 08/15/2010, [REDACTED] (daughter) and [REDACTED] (niece) had went to Mitchell Park in East Moline, IL to play basketball and observed [REDACTED] and a older male, possibly Hispanic, meeting in the parking lot.

[REDACTED] advised after receiving this information, she asked [REDACTED] to look at a picture of Jeff Terronez which they obtained via the internet. [REDACTED] advised the picture of Jeff Terronez was the individual which she had seen on 08/15/2010 at Mitchell Park with [REDACTED]. [REDACTED] then called her sister [REDACTED] and asked her to show [REDACTED] the same internet picture of Terronez. [REDACTED] also advised that the picture was the person who she observed with [REDACTED] at Mitchell Park.

The following is a synopsis of the recorded interview with [REDACTED]

[REDACTED] advised on approximately the third day of school, possibly a Friday, a couple weeks ago she had overheard a conversation between [REDACTED] (F/W, DOB: [REDACTED] hereafter referred to as [REDACTED] and [REDACTED] (F/W, DOB: [REDACTED] in the lunch room at [REDACTED] during lunch hour. [REDACTED] was telling [REDACTED] that [REDACTED] had stopped by [REDACTED] boyfriend's house. According to [REDACTED] [REDACTED] had told her that the State's Attorney had purchased her alcohol. [REDACTED] asked [REDACTED] if she was having sex with him, and [REDACTED] giggled.

The following is a synopsis of the recorded interview of [REDACTED]

[REDACTED] advised that prior to Sunday 08/15/2010, she had previously heard rumors about [REDACTED] and the State's Attorney, and that the State's Attorney had given [REDACTED] alcohol, and they have had sex. [REDACTED] advised she had never seen the State's Attorney and did not know his name at that time. I asked [REDACTED] to just tell me what she has seen and heard excluding the rumors.

[REDACTED] advised on 08/15/2010, at approximately 6:30 PM - 7:00 PM, she went to Mitchell Park in East Moline, IL with her cousin [REDACTED] (F/U, DOB: [REDACTED] (11) her brother, [REDACTED] (6) her sister, [REDACTED] (9) [REDACTED]

brother, and [REDACTED] (1) [REDACTED] son. [REDACTED] does not think that the children present knew what was going on, but knows that [REDACTED] does. [REDACTED] related upon arriving at Mitchell Park, she observed [REDACTED] with a male, approximately 36 years old, unshaven, wearing a gray shirt, hat, sunglasses, and driving a small black car with a small white stripe, similar to a Corvette. [REDACTED] thought at first it was [REDACTED] father because they were arguing. Then when they quit arguing and started giggling she did not think it was [REDACTED] father. [REDACTED] recalled when she first arrived at Mitchell Park, she thought that the older male was looking at [REDACTED] vehicle and believes they opened the trunk. [REDACTED] advised that [REDACTED] and the male were present at the park for approximately one hour. During this time [REDACTED] talked between [REDACTED] and herself about the person [REDACTED] was with. [REDACTED] offered that [REDACTED] took a picture of the male with [REDACTED] on her cellular telephone.

After [REDACTED] left the park, she told her Mother, who had [REDACTED] look at a picture of Jeff Terronez on the internet. [REDACTED] felt this was the person with [REDACTED] I asked [REDACTED] how sure she was. [REDACTED] stated she was 100% sure it was the State's Attorney. I asked how far away [REDACTED] was from [REDACTED] and the male. [REDACTED] estimated she was 10-15 yards from [REDACTED] and the male subject.

The three recorded interviews were held on my digital recorder in my official state vehicle (OSV) after the interviews. On 08/23/2010, I downloaded the three interviews from my digital recorder onto a CD and made two working copies. The [REDACTED] CD was labeled exhibit #1, and was subsequently place in a temporary evidence storage (TES) locker at ISP, Zone 2 Investigations, Sterling, IL office (Z-2 ST). On 08/27/2010, at approximately 4:30 PM, exhibit #1 was retrieved from the TES, packaged, and placed in ISP, Z-2 ST, evidence drop locker (EDL) #20.
